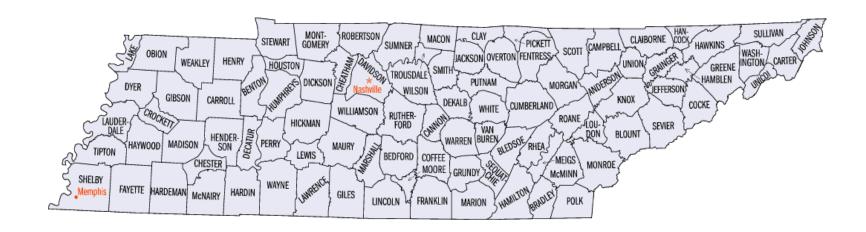
DBE Program Basics

- Governing US DOT Regulation
 - 49 CFR Part 26 and Participation by DBEs in Department of Transportation (DOT) Financial Assistance Programs
- MTA & RTA Responsibilities
 - Establish Overall Goals (every three years)
 - Determine Contract Goals
 - Certification
 - Performed as part of the TNUCP
 - Monitoring and Enforcement
 - Reporting

Establishing Overall Goals

- 49 CFR 26.45 requires an transit agencies to set overall DBE goals for FTA-funded projects.
- Overall goals must be based on demonstrable evidence of the availability of ready, willing and able DBEs relative to all businesses ready, willing and able to participate in the transit agency's FTA-funded contract opportunities.
- Goal must reflect the level of DBE participation MTA
 & RTA would expect absent the effects of discrimination.
- Development of future goals considers previous attainments.

DBE Goal Setting Process

Goal-setting is a two-step process:

- 1. Establish a base figure based on the relative availability of DBEs to participate in FTA & RTA FTA-funded projects.
- 2. Make any necessary adjustments to the base figure based on local market conditions.

Step 1 - Calculating the Base Figure

- The goal focuses on the participation of DBEs in FTAfunded contracts that will be awarded over the next three federal fiscal years.
- Potential projects are forecasted three years into the future.
- This provides a "best estimate" of potential contracting activity and opportunities.

Projecting Race-Neutral/Race Conscious Split

- Once the overall goal is established, MTA & RTA must project what part of the goal it anticipates achieving race-neutrally (i.e., no DBE goals set on agreements/contracts) and what portion it anticipates achieving race-consciously (i.e., setting a goal).
- Based on past participation, for its 2021-2023 goal, MTA projects attaining 5% race neutrally and 9% race- consciously.

Proposed Overall Goal for MTA & RTA FY 2021 – FY2023

MTA projects to spend approximately \$27 million in FTA funds for professional services, construction and equipment/materials.

5% race neutral and 9% race- conscious

RTA projects to spend approximately \$6.5 million in FTA funds for professional services, construction and equipment/materials.

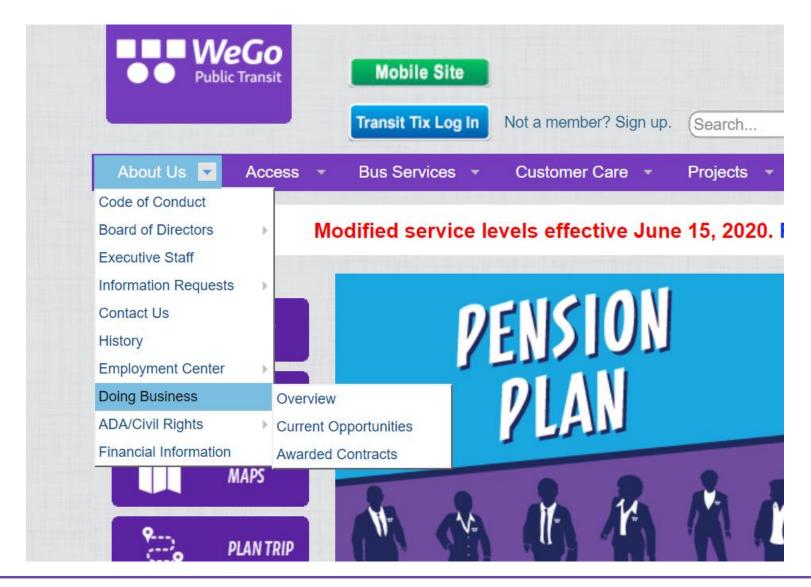
